Refer a Friend Program Terms and Conditions

- 1. Terms that are capitalised in the present Terms and Conditions of the Refer a Friend Program have the same meaning as the terms used in the General Terms and Conditions of the Platform User Agreement (https://www.mintos.com/en/doc/user_agreement) unless indicated differently in the present Terms and Conditions of the Refer a Friend Program.
- 2. The Refer a Friend Program is valid from January 2, 2020 to December 31, 2020.
- 3. During the time frame indicated in Clause 2, any Mintos User has the right to participate in the Refer a Friend Program, if the Mintos-generated unique promo code or link (hereinafter the Code) is available on the User's Virtual Account.
- 4. The User is prohibited from using the Code in any way that differs from Mintos' values or in any other way that may qualify as an unfair commercial practice, as determined at Mintos' sole discretion. referred party, of all outstanding principal amounts of loans and/or invoices held by the referred party within the respective Bonus Period as follows:

- 8.1. For the referred party's investment balance of EUR 500 to EUR 999.99 , The User and the referred party both get a EUR 10 bonus;
- 8.2. For the referred party's investment balance of EUR 1 000 to EUR 2 499.99, The User and the referred party both get a EUR 20 bonus;
- 8.3. For the referred party's investment balance of EUR 2 500 to EUR 4 999.99, The User and the referred party both get a EUR 30 bonus;
- 8.4. For the referred party's investment balance of EUR 5000 to EUR 9 999.99, The User and the referred party both get a EUR 60 bonus;
- 8.5. For the referred party's investment balance of EUR 10 000 and more, The User and the referred party both get a bonus of 1% of the total of the outstanding investment amount.
